By <u>signing up for a partnership</u>, you agree to the following regarding your partnership of the All Ohio 2022 Symposium.

- 1. Conference Space: We understand that sponsorship is on a first-come, first-served basis. Our application will be considered complete when our signed partner application, logo, and payment are received. Upon processing, we will be notified that our application has been approved.
- 2. Partner Protocol:
 - a. Our company materials will be confined to the four- or six-foot draped table.
 - b. We are responsible for set-up and removal of our promotional materials. At our expense the venue may provide additional services (such as additional AV, return shipping).
 - c. We understand that we will set up an account with the hotel to cover the cost of their receiving our shipped materials.
 - d. We understand that the exhibit hall is not secure and that we assume sole responsibility for security of items left at our exhibit table.
- 3. Cancellation and Unforeseen Events
 - a. We understand that we may submit a written request for cancellation by July 1, 2022. The Conference will refund our sponsorship payment less \$1,000 to cover costs incurred.
